# **Irving Oil Dump Station Update:**

Terry informed the Commission that our Solicitor has contacted the Lawyers of Irving Oil and they have welded the cap on the dump station, and in the spring they will reroute their storm water so that it does not go into our sewer.

# Other Business: Wells:

Terry Silver informed the Commission that she has received concerns for our Engineer Doug Seamone regarding the number of non-functioning wells. Until this week, only one well was pumping into the Woodvale tank and Doug Seamone was looking for money to drill the Seniors Well. There was enough money in the budget to put a new pump in the Jones Well # 2 and for now, that well, combined with the Towers Well, are supplying the tank fine. The New Jones Well should be up and running in a couple of weeks and we will be looking to put money in the next year's budget.

### Sand & Grease Traps:

Terry informed the Water Commission that according to our solicitors we are unable to shut down sewer, but we can clean sand and grease traps out and bill the businesses for the work. Should they not pay, The Village will place a lien against the property. The bylaw has a provision for placing fines on offenders, or jail time if found guilty.
